

RSA holds fundraiser for AIDS camp

The Resident Student Association is doing its part in the fight against AIDS by raising money for Camp Heartland, a week-long camp held during the summer for children infected with or affected by HIV or AIDS.

Camp Heartland provides recreational opportunities, support and AIDS education for its participants. RSA, the governing body of resident students, has begun its annual fund-raiser for Camp Heartland.

Sophomore Andie Ward, the foundations director of RSA, said the average amount RSA raises each year is around \$1,000, about the cost of sending one child to the camp. "Eventually in the future, we'd like to bring them down to do a presentation. They'd bring campers so we could see first-hand. It would be a neat program to have on campus. Unfortunately, it is not allocated in the budget," said Ward.

Camp Heartland was established in 1993 for children with AIDS. Since the first camp with 75

children, the number has grown so much that there is now a waiting list to attend. Camp Heartland also provides peer education/AIDS awareness seminars to encourage youths to do their part in eliminating the tragedy of AIDS.

The program is based in Wisconsin, but the camp itself is mobile, with different locations each year. The ultimate goal of Camp Heartland is to purchase a permanent campsite that can be used as a year-round retreat and education center. The center would be open for children infected with HIV or AIDS, their families and AIDS orphans.

Ward said that RSA would like to sponsor a child from the Winston-Salem area, but problems concerning privacy and getting a child from Winston-Salem on the waiting list have prevented it from doing so thus far.

RSA has been aiding this philanthropy since RSA's formation in 1988. Each year, RSA donates money to support the camp.

RSA has two major fundraising campaigns for Camp Heartland this year. Faculty fundraising has already started with Heart-to-Heart, in which

faculty, staff and administration are asked to donate money to the cause.

The other campaign is run through the residence halls. RSA officers from each residence hall come up with a fund-raiser for their residence hall to participate in. The hall can also donate money out of its allotted budget.

Camp Heartland is the only cause for which RSA raises money. During this semester, RSA has been trying to come up with ideas of fundraisers within the dorms. Most of the fundraisers will be carried out in the spring semester. Johnson Residence Hall, however, has already finished its fund-raiser, "penny wars" between the halls.

RSA will also have T-shirt sales in the spring and all the profits will go towards Camp Heartland.

Residence Hall Week which begins on Nov. 17 will have a few activities in conjunction with their fund-raiser. The week will honor all aspects of residence life. On Nov. 18, a speaker from the AIDS task force will speak on AIDS awareness.

RLH enforces lounge inspection policy

According to Connie Carson, the director of Residence Life and Housing, any leased lounge or blocked housing can be inspected at any time. This includes fraternity and sorority houses, their towers and any other lounge leased from the university.

This policy has been in effect for years, but typically lounges and block housing are only inspected once a week.

Each week, a trained person from

RLH does an inspection and fills out a form rating safety; health and cleanliness; maintenance and compliance with university policy, Carson said. For instance, if liquor is found during an inspection this would be reported, because liquor is not permitted on campus, she said.

Carson said that the reason there have been some abnormal inspection times recently is that because RLH temporarily did not have a full time employee to conduct inspections, so another employee was fulfilling this duty in addition to

his other responsibilities. This employee was just doing these inspections when he could get to it, Carson said. According to Carson, RLH does not perform inspections at night or when an organization is having a function. She also said that organizations are given a time frame to do a general clean up the night of the function and are expected to get their final clean up done the next morning. She also said that all block housing is expected to be clean at all times.

"Real failure (of inspection) takes quite a bit. It's rare," she said.

"Only one or two groups have actually failed inspection this year." She said that groups can occasionally get low scores without failing their inspections.

If an organization does have any damages reported, the group is billed for the repairs, Carson said.

Carson said that all house managers and organization presidents go through training, so they become familiar with all of the policies regarding their lounge space. They are also given copies of the forms that RLH uses to assess the condition of the lounges.

Kappa Sigs to learn fate today

The results of an investigation into the pledge practices of Kappa Sigma fraternity will be released by the university today. If found guilty of hazing, the fraternity will face sanctions ranging from a warning to the possible revocation of their charter.

The Kappa Sigs will learn their fate at a meeting today with their faculty and alumni advisors, and members of the administration according to Harold Holmes, an associate vice president and the dean of student services. Holmes conducted the investigation that has been going on since one month ago today.

"These gentlemen will find out what the outcome of all these weeks of waiting is," Holmes said.

The exact allegations against Kappa Sigma have not been released, but many administrators have emphasized the severity of the charges. "This is not normal in many respects for Wake Forest, in terms of the severity of the allegations and such," Holmes said. If found guilty, the fraternity has ten days to appeal Holmes's decision to the Student Life Committee. "It is in the hands of the young men. They will either accept the findings in the letter ..., or they will appeal," Holmes said.

The investigation into Kappa Sigma's pledge activities began Oct. 13. The exact allegations were not released by the university. A preliminary hearing Oct. 22 in front of the Group Advisory Panel was the "primary vehicle through which the information gathering occurs," according to Holmes. The administration interviewed every fraternity member after the hearing.

The Group Advisory Panel made a recommendation to Holmes after the hearing, but that recommendation is confidential. Holmes spent the two weeks since the hearing investigating the matter further.

The Division of Student Life is going to release the finding and sanctions to the *Old Gold and Black* as soon as they are released to the fraternity. The decision to release the report was made by the Division of Student Life. "There have been reports in the media and it's important that we provide information," said Ken Zick, the vice president of student life and instructional resources.

Area television stations have aired stories about the hazing allegations in recent weeks.
